CONSENT TO PERSONAL DATA PROCESSING

I, in accordance with Paragraph 4 of Article 9 of Federal Law No. 152-Φ3 On Personal Data dated 27.07.2006, hereby give my consent to Individual Entrepreneur Loshkarev Ivan Sergeevich, TIN 246401463907, PSRN 320200000000411 to the processing of my personal data on www.grace-global.ru (hereinafter, the "Website"), as well as in any of the accommodation facilities of the GRACE group of hotels, to render booking, hotel, excursion, and other services of the GRACE group of hotels and its partners presented on this website, publishing reviews, informing on special offers, fulfilling the duties of the resort fee operator, as well as storing all the above data on electronic and paper media, for which purposes the Personal Data Operator (hereinafter, the "Operator") collects and uses personal data to process the Customer's request on the Website, as well as in any of the accommodation facilities of the GRACE group of hotels, when making a booking, and/or transmitting data to the temporary accommodation facility selected by the Customer, as well as for prompt and high-quality consultation of the Customer on clarifying or changing the booking.

Personal Data shall mean any information relating to a directly or indirectly identified or identifiable individual (citizen).

Personal data processing shall mean any action (operations) or aggregation of actions (operations) performed with the personal data subjects' personal data with or without using automation tools. Such actions (operations) include the following: collection, receipt, recording, systematization, accumulation, storage, clarification (updating, modification), extraction, use, transfer (distribution, provision, access), depersonalization, blocking, deletion, destruction of personal data.

The Operator will receive information on the IP address of the Operator's Website visitor. This information will not be used to establish the identity of the Website visitor.

The processing of personal data shall be carried out with the Customer's consent. Being a Website user, the Customer provides his/her personal data and gives full consent to the processing thereof. Obtaining consent to the personal data processing shall be a required condition for booking the services. Booking of services will not possible and will not be completed without obtaining the Customer's consent to the processing of his/her personal data.

I provide this consent in accordance with Article 9 of Federal Law No. 152-Φ3 On Personal Data dated 27.07.2006, for performing the service agreement terms and conditions defined by the Parties freely, voluntarily, and in their own interests; I consent to the processing of my personal data (name, patronymic, surname; date of birth, passport data (series, number, issue date, issuing authority name), nationality; residence address (as per the passport, actual address), telephone and/or mobile telephone number, e-mail address; national passport / international passport number and validity term; name and surname as indicated in the national passport / international passport; name and details of documents confirming the person's right to exemption from payment of the resort fee; other information, strictly to the extent required for rendering the services as per the service agreement and performing the contracts whereto the Operator is a party, as well as for the activities of other third parties directly rendering services, as well as performing other actual actions related to the services under the Agreement. I may revoke this consent in writing. This consent shall be valid from the date of its signing until the date I revoke it by sending the Operator written notice of the said revocation in any form unless otherwise stipulated by the legislation of the Russian Federation.
